In consideration of being permitted by Saddle Creek HOA, Inc., to utilize their community pool facilities (the "pool"), I hereby waive, release and discharge any and all claims for damage for personal injury, sickness, death, or any other damage which I may have, or which may hereafter accrue to me or my minor children, as a result of my use of the pool. This release is intended to release Saddle Creek HOA, Inc., its board of directors, agents, management company, and

attorneys, from any and all liability arising out of or connected in any way with my use of the pool, even though that liability may arise out of negligence or carelessness on the part of those parties. It is understood that my use of the pool involves an element of risk and danger of accidents and knowing those risks, I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold harmless, Saddle Creek HOA, Inc., it's board of directors, agents, management company, and attorneys from any loss, liability, damage, cost or expense which they may incur as the result of my death or any sickness, injury, or other damage that I may sustain while utilizing the pool.

I agree to abide by any and all rules and regulations implemented by the Saddle Creek HOA, Inc. board of directors with regard to my use of the pool. I further agree to abide by all local, state, and national rules, regulations, orders and laws with regard to the use of the pool.

CONSENT OF PARENT/GUARDIAN (If there are minor residents)

I HAVE CAREFULLY READ THIS WAIVER AND RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND SADDLE CREEK HOA, INC. AND I SIGN IT OF MY OWN FREE WILL. I FURTHER REPRESENT AND WARRANT THAT I HAVE THE AUTHORITY TO EXECTED THIS WAIVER AND RELEASE ON BEHALF OF ANY MINORS LISTED ABOVE.
