December 3, 2020

- -Meeting called to order.
- -Roll Call Anita Dunkin, Brenda Hiler, Rick Bennett present. Quorum established.
- -Report of Board Activity for 2020:
 - 1. Retained attorney for guidance in setting up the homeowner-controlled board correctly.
 - 2. Purchased Director's and Officer's coverage. New insurance cost \$5,500.00 annually.
 - 3. Created and updated new homeowner website.
 - 4. Set up accounting on Quick Books online. This gives the Board the ability to email invoices for dues and collect payments online.
 - 5. Delinquencies were at \$30,000 as of July 2019. All of that was collected by the end of 2019. 100% of 2020 dues were collected by April 20, 2020.
 - 6. A survey was sent to the neighborhood to determine the areas of concern and Teams were organized accordingly.
 - 7. A budget for 2020 was established.
 - 8. Pool repairs were made.
 - 9. The Board did extensive planning and preparation for opening the pool during the COVID-19 pandemic.
 - 10. The Board worked with the County Commissioner and the County Attorney concerning July 4th Celebration, and had multiple conversations with the Commissioner regarding Stousland and IG&N roads.
 - 11. First email blasts were sent and will be used for continued communication with the homeowners.

-Financial Report

- 1. By obtaining bids for all expenses, the Board was able to cut \$5,000 off of the 2020 budget in expenses.
- 2. HOA will spend approximately \$15,000 to replaster and make additional repairs to the pools prior to 2021 opening.
- 3. HOA incurred \$1,575 in additional legal expense with setting up the Board, and receiving advice and guidance on the waivers/releases for the pool.
- 4. Added expense of \$2,000 in 2020 for the pool attendants.
- 5. Current reserve account balance is \$7,500. Plan to add another \$7,500 in 2021.
- 6. Collected a total of \$2,000 in Title Transfer fees in 2020.
- 7. Current checking account balance is \$2,553.85.

Due to the Management change, we have allowed owners an extra 30 days to make payments free of charges. On March 1st, we will apply late fees and/or interest, in accordance with the Saddle Creek CCR's. We are continuing to work on collecting that balance. Owner's who wish to check the status of their account can log in to their Owner's Portal to see if there is a balance, or email to request a statement.

Violation Report: None to report at this time. Our initial property drive will take place before March 5th.

Team Reports:

Events team

The Events Team is looking forward to planning more fun community events this year. It goes without saying that we will continue the tradition of our annual Fourth of July parade and fireworks celebration, and we are planning to rent dumpsters for a Spring Clean-up event for neighbors who are looking to discard large items. The date will be announced soon. Other events that we are discussing include a spring (and possibly fall) vendor market, food trucks, kite flying contest, street dance, Geocaching, Flag day celebration, nature park clean-up day, fitness challenges, as well as other ideas. Let us know if you would like to help out, or if you have any other suggestions.

Architect Control team

Last year, the ACT received 36 submissions for exterior changes. This year is also starting out busy with 7 submissions already received.

The ACT is now receiving submissions through the Beal portal so all diagrams and documents can be uploaded into the portal. It would be very helpful if all Homeowner's remember to also upload the cover document that answers the basic overview questions and provides the HO contact information in case additional information is needed. About 50% of the submissions we receive require additional information in order to approve. In order to protect the property values and aesthetics of the neighborhood, the CCR's require that all exterior improvements need ACT approval. Note that this includes sheds or outbuildings that are not

Improvements Team

The action plan for this year includes:

- Beginning the process of upgrading the landscaping in the common areas. The first priority will be the entrance monument. A master plan for future years has been created to also provide new landscaping at the pavilion and pool area, and improve drainage in those areas.
- Upgrading and repairing the pavilion. Several areas have suffered water damage and will need repairs. Additionally, wifi and security improvements are in the works.
- The Yard of the Month (spring/summer) and Holiday Decoration (fall/winter) contests will continue.
- Two bluebird houses will be installed on HOA property. If feasible, one may have an internal video camera with remote viewing available.
- A trailhead kiosk will be installed at the nature trail with signage and interpretation. The team is working with trail neighbors to develop rules for the area and future plans for managing the property. All neighbors interested in the nature trail are encouraged to get involved.

Project Reports:

Clear Water is out this week to do the work they need to do on the filters and pumps. The pool re-plaster is scheduled to begin next week, weather permitting.

Winter Weather Update: As of today, everything seems to have made it through the winter storm with no damage.
