Drainage Easements

Saddle Creek is blessed with several natural creeks and ponds that help our overall drainage in the subdivision after heavy rains. All ponds in Saddle Creek are private, and owned by the property owners that own the land where the pond is located.

As much as possible, the layout of our lots took into consideration the natural typography of the land by establishing lot lines along the natural creeks and low areas. Additional drainage ditches were added to help with the water flow.

Our CCR's require owner's to keep the drainage easements free of obstructions. Please be sure that the ditches on your lots are maintained so that storm water runoff is not impeded.

Each lot has a 10 foot utility and drainage easement surrounding the entirety of the lot. In addition, there are standard 25 ft. side and rear setbacks plus a 50 ft. front setback for most lots.

Numerous lots throughout the subdivision also have additional drainage easements that alter the standard setback requirements.

If you plan any projects, be sure to review your own lot survey to check easements on the sides and backs of your property.

As many of us are doing cleanup of trees and bushes that didn't survive the drought, please be careful that any debris does not block drainage ditches or culverts.

Thank you to all for helping to keep Saddle Creek beautiful.

Halloween Safety

- Watch out for traffic drivers might not see you.
- Please drive slowly, watching for small children.
- UTV drivers keep lights on.

- Adults: always accompany your children when they are trick-or-treating.
- If you are wearing a mask make sure that you can see where you are going and are aware of your surroundings.
- Carry a flashlight or glowstick and a fully charged mobile phone (if you have one).
- Wear bright colors and/or add reflective tape to costumes.
- Be careful of lantern flames igniting costumes. Ideally, use battery powered LED candles.
